SERVICE LOCATION AND REQUIREMENTS: Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the stylist needs to complete the party. TRAVEL FEE: The amount will be determined at time of inquiry based on the location. This includes travel to destination and return for all service providers.

PAYMENT: Acceptable forms of payment are Cash, Venmo, or PayPal. Prices listed do not include any gratuities.

CANCELLATION POLICY: Cancellations must be made sixty (60) days prior to your reserved date or you will be responsible for the entire amount of services agreed upon in this contract. In the event of any cancellation, the deposit/travel fee remains non-refundable.
