### *Terms & Agreement*

**SERVICE LOCATION AND REQUIREMENTS:** Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the stylist needs to complete the party. A “set up” table/work area needs to be made available for the stylist(s) at said location. Ample lighting, either natural light or by lamps, is necessary for services to be performed properly, electricity must be available. All hair must be clean & dry. Faces must be washed, moisturized and free of make-up.

**PHOTO/VIDEO RELEASE:** Authorization and grant for Piccola staff and hired persons to take photos pertaining to the wedding day, such as venue, decor, attire, services rendered, etc. Piccola may use photos on Facebook, Instagram, and other social media platforms. Piccola has authority to edit, alter, copy, or distribute the photos for social media advertising and marketing. Photos taken by Piccola team belong to Piccola Salon and Spa. Monetary compensation will not be received for photos taken and/or shared.

**TRAVEL FEE:** The amount will be determined at time of inquiry based on the location. This includes travel to destination and return for all service providers.

**PAYMENT:** Acceptable forms of payment are Cash, Venmo, or PayPal. Prices listed do not include any gratuities.

**CANCELLATION POLICY:** Cancellations must be made sixty (60) days prior to your reserved date or you will be responsible for the entire amount of services agreed upon in this contract. In the event of any cancellation, the retainer/travel fee remains non-refundable.
